## ***Code of Conduct***

Amador Jr. Buffalos Football & Cheer believes that participation in our program teaches citizenship, teamwork, good sportsmanship, and the fundamentals of the sport. Jr. Buffalos athletes are easily recognized in the community and should serve as positive role models for other youth in the community. For these reasons, we have the following Code of Conduct to be adhered to on or off the field, at all times, during the entire Jr. Buffalos season.

1. A Jr. Buffalo athlete's education comes first. Jr. Buffalo athletes are encouraged to maintain a minimum grade point average of 2.0, with no failing grades.
2. A Jr. Buffalo athlete will abstain from the use of the following substances for the entire season:
  - a. Tobacco in any form
  - b. Alcohol in any form
  - c. Drugs of any kind (including marijuana) not prescribed by a doctor
3. It is the responsibility of the Jr. Buffalo athlete and his/her parent or guardian to demonstrate positive behavior that reflects good sportsmanship and citizenship. Athletes and parents or guardians will abstain from the following:
  - a. Obscene or profane language
  - b. Unbecoming conduct to others, including but not limited to bullying and/or belittling remarks or actions toward other players
  - c. Fighting of any kind on or off the field
