Code of Conduct

Amador Jr. Buffalos Football & Cheer believes that participation in our program teaches citizenship, teamwork, good sportsmanship, and the fundamentals of the sport.  - b. Unbecoming conduct to others, including but not limited to bullying and/or belittling remarks or actions toward other players
 - c. Fighting of any kind on or off the field
